The boiler filters have been installed for \$7,200. They require \$1,000 for maintenance.

- Carpeting We can have all three big buildings recarpeted for \$67,000. Another bid for the carpeting at 10/14 came in well below the \$43,000 that was approved in the vote.

 - We will need to have owners vote to carpet 1&5 and 2&6 since the bids are over \$15,000. This vote will happen in July.
